

Shower Head Installation Instructions

Tools needed: Wrench (to remove old shower arm) and Plumber Tape

1. Preparations


Before you begin installation: Remove the old shower head from the shower arm. Remove any excess materials left on the threads of the shower arm and wrap Plumber Tape around the threads.




2. Installation

Wrap Plumber Tape around the threads on the shower arm and carefully hand-tighten the adjustable arm nut onto the shower arm clockwise. Position the adjustable arm straight (shown below). If the arm spins after tightening, use a wrench to tighten the <u>nut</u> until the arm is held in place.

DO NOT overtighten.



Wrap Plumber Tape around the threads on the adjustable arm and carefully hand-tighten the metal nut of the shower head clockwise onto the adjustable arm.



For surface cleaning of parts, use water and soap. Dry with a soft cloth. Note: Any other cleaning product not specifically designed for cleaning plastic or metal surfaces may damage the finish.

Lifetime Shower and Finish Limited Warranty: All parts and finishes of the Delta® showers are warranted to the original consumer purchaser to be free from defects in material & workmanship for as long as the original consumer purchaser owns their home. Delta Faucet Company recommends using a professional plumber for all installation & repair.
