This system includes an electronically actuated Pop-up drain. The whole system is powered by a Listed Class 2 direct plug-in power supply. The electronic shower system consists of a power supply, water valves and a low-voltage controller. The only connection is on the low-voltage side that provides power and control signals. The power supply provided is a limited energy and double insulated. The non-contact faucet consists of a low voltage controller, solenoid valve, low voltage sensor, and Listed Class 2 direct plug-in power supply. The connections on the low voltage side control the solenoid, and provides power. These products are intended for indoor use only. These products are intended for installation per the manufacturer's instruction in accordance with the latest edition of National Electric Code and Canadian Electric Code.

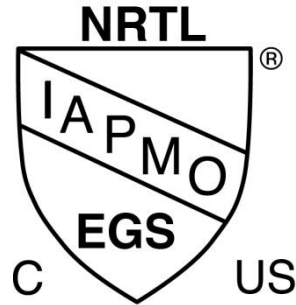
